



## Technical Evaluation Criteria for Bids Competition

### Evaluation Criteria

All bid offers will be evaluated according to the following table using the “Degree” method. Offers that considered as technically acceptable will pass to the next stage which is the financial evaluation.

Technically acceptable means the offer provided mandatory criteria and has Pass degree 3/5 at most of criteria in general.

### The Definition of “pass” Criteria:

#### 1. Relevant past performance experience for similar projects (supply of desludging trucks), (Mandatory)

The “Pass” criteria will be given for offers that have relevant experience in the construction of water supply network in the in the last five years. Bidder should submit evidence for this past experience such as contracts with successful completion certificate, project delivering certificates, payments, etc. Experience with IOM/UN Agencies/INGOs/NGOs related to the humanitarian projects in the last five years is an advantage.

*The bidder will be **excluded** from technical evaluation if this criteria is not fulfilled.*

#### 2. Technical specifications with and manufacturer’s catalogs, brands, country of origin, components specifications, accessories..etc (Mandatory)

The “Pass” criteria will be given for offers that submit high-quality materials with well-known brand names and well-known countries of origin, technical specifications in line with the Bill of Quantities and ToRs, and with manufacturer’s catalogs, quality certificates, etc. The documents should be for main items like Engine specifications, Chassis, Superstructure, suction pump, vacuum system, accessories, etc. Only high-quality materials which are cost-effective will be considered.

*The bidder will be **excluded** from technical evaluation if this criteria is not fulfilled.*



### **3. Certificates and warranties after sale.**

The “Pass” criteria will be given for offers that submit Manufacturer Warranty: at least 1 year and half warranty against manufacturing defects (Warranty certificate).

### **4. Detailed delivery plan,**

The “Pass” criteria will be given for offers that submit a logical time-effective delivery plan. The schedule should show the different period of delivery stages from the time ordered from the manufacturer, assembly stage, and up to the final delivery date point (Gantt-chart can be used). The delivery plan should be clear and applicable.

### **5. Company profile**

The “Pass” criteria will be given to offers that submit a good profile which mention the company scope of business, past projects, labor capacity, equipment capacity, etc. The profile should be written in professional way and represent the company. Supporting documents can be CV’s of management and engineers, contracts, appreciating certificates, pictures, etc.
